- Vendor locations are not held in advance.
- Vendors are requested **not to leave until fifteen minutes after the event is over**. Vendors leaving early will not be invited to future events.
- To avoid duplication of food sales, **food sold must be approved in advance on a first come, first serve basis**. Please only sell foods that you have received permission to sell. Food vendors may sell non-alcoholic beverages.
- **Food vendors must secure a permit and conform to the Monterey County Health Department regulations**. The Health Department will be strictly enforcing their rules. Information and requirements can be obtained by calling the Health Department at 647-7654.
- Vendors must pay in advance.
- **Food Vendors must accept food vouchers from Band members to be provided a meal and a drink at no cost. The City of Seaside will not be refunding the cost for the meal provided in exchange for this voucher.**
- When setting up your booth space please be respectful of your neighbors space as well.
- All vendors should not arrive **until 12:00 p.m. Please do not arrive earlier and please wait for staff to show you your location. All vendor vehicles must be off the lawn by 2:00 p.m.**
